- 1.2 Additions or Deletions not anticipated 48 hours in advance Revise 1.3 (Septic permits for review) to New construction septic permit 25 Harbor Trace Rd. Also add agenda item for Board to sign final draft of subsurface sewage disposal regulations.
- 1.3 New construction septic permit 25 Harbor Trace Rd. Board reviews plan and determines proposed system to be fully compliant. GB motions to approve the plan as submitted and sign the construction permit. JL 2nd. Unanimous Approval.
