A motion was made by Chaz Sexton-Diranian and seconded by Joe Shank to approve the BAN note from Treasurer in the amount of \$881,200 with Newburyport Five Cents Savings Band at 1.66% (lowest bid of 2 bids) to cover borrowing for water main project and initial work on bridge replacement.

Public Hearing: All-Alcohol Liquor License, Townsend VFW Post 6538, 491A Main St, West Townsend

Public hearing was opened at 5:42 p.m.

Abutter notifications were reviewed. All received except those sent to Comm of MA Fish&Wildlife.
