2.1.2 9:30 AM -10:20 AM Public Safety Board of Selectmen meeting called to order at 8:31 a.m. with Chaz Sexton-Diranian, Theresa Morse, and Veronica Kell present.

The Finance Committee also called their meeting to order.

Pledge of Allegiance recited. Chaz Sexton-Diranian thanked all those who have served.

It was announced that the meeting is being recorded and will be posted.

There were no additions or deletions to the agenda.

It was noted that the budget draft being reviewed is dated 3-9-2023. Salaries have 2% COLA with 2% step if eligible. Budget allows for 2.6% increase for school budgets which is more than net school spending. School is requesting SOOK+/- more than what we have budgeted. An override will be required.

General Government budgets reviewed in available time:

- 1. Assessor only increases in salary/wages lines and for Patriot eval. Training increased for succession plan.
- Town Clerk discussion of reallocation/allocation of ARPA funds for poll pad maintenance vs. clickers. One fewer election expected in FY24.
- 3. Facilities Increase for admin asst; Questions on specific use of funds requested. Questions were asked; no votes were taken.

The remainder of General Government will be reviewed later in the meeting. [break - 5 mins]

Public Safety budgets reviewed in available time: (ARPA being used as revenue source)

- Police Chief Sartell provided an additional handout; request for revolving fund (Fingerprinting; firearms licensing) to be used for public records; use of some ARPA funds.
- 2. Fire ARPA funds will be used in FY24 Questions were asked; no votes were taken. [break 5 mins]

Department budgets were reviewed in the following order:

1. Board of Health and Landfill - noted that the override for trash pickup many years ago was for \$600,000 but \$755,389 is being

2. Council on Aging - opening of 2000 sq ft addition; participation at Sr Ctr has increased by 30% for an average of 85-90 people/day.

Library-4 hrs added to Young Adult librarian (tech director) and 1 hr to staff. The library will stay open one hr longer on Tues./Wed/Thurs.

Recreation - Question on salaries and hours for Dept Head and Assistant Director.

Discussion of IOK added to Fin Com Reserve Fund.

Discussion of Housing Authority and Housing Trust budgets. The Housing Trust budget is ARPA funded.

Town Counsel - No rate for FY24 has been received as of yet.
