Re: Letter of Resignation

Dear Ross:

Kindly inform the Board of Selectmen that I hereby resign my position as Fire Chief for the Town of Townsend.

Without retracing the entire history of the unfair and discriminatory treatment I have received at the hands of the Board, I must make it clear that this is being done under the greatest amount of duress. Nothing herein should be construed as a waiver of my rights, especially those under the federal and state Family and Medical Leave Acts. However, as the Board has persisted in its harassing and punitive conduct, I want to leave under conditions where the Board will not have the opportunity to fabricate any basis for not paying me the severance amount called for in my employment contract. That, amounts to 3 remaining weeks of vacation and seven weeks of severance totaling 10 weeks of pay. If your calculations differ, kindly so inform me immediately when sending me whatever amount you feel is owed. In any event, as you know, failure to pay for accrued vacation upon separation may result in treble damages liability and enforcement by the Attorney General's Office.
