1.0 Preliminaries

3.1 Compliance Issues

3.1.2 22 West Meadow Road – MT-We believe that they will need a NPDES permit and will pass that along to the issuing authority, which is the EPA. Member of the audience, Veronica Kell asked if this was for the solar panels or sand. MT- sand.

3.1.3 59 West Meadow Road – MT- We are still waiting to hear from Joseph Iodice. Veronica Kellasked why we went to the site. DH- We received complaints in regards to gravel removal.

3.1.4 529 Main Street- MT- has been going back and forth with the attorney, Mr. Bowen. There may be more issues within the stream. We have been in touch with DEP and are looking for the Dows to show that they qualify for the agriculture exemption. The Amadons have demonstrated that the hay is being harvested for agriculture. JD- is concerned that the bank is not properly stabilized and that it will lead to problems in the future. Discussion went on about the work involved in the permit that was previously issued. Would like to ask DEP if we can hold them responsible if issues arise. MT- We will do another site walk and let DEP know if there are any issues or concerns.
