**Applicant:** Stan Dillis for Joseph Lopalito

**Location:** Warren Road

**Project:** Request to change acreage of land offered as mitigation

Stan Dillis and Mr. Lopilato were present. DH had some questions in regards to perpetuity. JL- perpetuity is defined as 30 years with possibility of a 20 year extension. JH- The town turned down the 8 plus acres mitigation land, at this point we should take what we can get. Once the final copy is submitted it will be forwarded to town counsel for review.

- **3.2** Squannacook River Clean-up- KH there are many areas that will need cleaning. KH went down the river and took photos and GPS of all area that will need work. The checklist has been submitted to NHESP.
- 3.3 Approve request to amend OOC for DEP308-604 10 Boutelle Road-MT recuses himself. KH is looking to add the installation of 3 light posts in addition to the installation of a stone wall at the entrance and removal of dirt berms in rear. The utility trench has already been dug. They will need a 2' x3' cement post,
- 2' deep. Applicant also request the mow within the 35' annually to prevent invasive species. CV- is the light posts under the elevation of the West's property? KH- Yes it it.
