## 2.0 Hearings and Appointments

2.1 7:05 pm	Request for Determination of Applicability TWB #2019-161
Applicant:	William Cadogan & Joan Savoy
Location:	35 Adams Road
Project:	Installation of a ground mounted solar, construction of a two car garage and extension
	of driveway.

JH opened at 7:07pm; Bill Cadogan (BC) presented revised plans showing existing driveway and driveway extension which is slightly in 100ft buffer. BC advised he is still not sure of trenches – he has to get DigSafe in due to existing pipes in the ground. JL requested a complete set of plans showing the planned trenches; JH reiterated he wants to see the trenches on the plans; BC advised he operates as a tree farm and requested an agricultural exemption – KH advised this is not on the agenda for tonight; BC is very concerned he is running out of time to accomplish his project; KH, JL & JH reiterated they need to see the trenching on the plans; BC requested a continuation. Solar contractor asked for clarification if anything besides the trenching needs to be shown on the plans. JH reiterated that all the work needs to be shown on the plans and to avoid the 35' no disturb area. KH motioned to continue to next meeting; AL seconded AIF.

Applicant:	Ducharme & Dillis for Diane Silva
Location:	59 West Meadow Road

**Project:** The proposed project is to restore historic wetlands and grades within the buffer zone to a 3/1 slope. Project is located within the ACEC and Estimated Habitat of Rare Wildlife

JH opened the hearing at 7:19pm, Stan Dillis present and advised the applicant had a biologist study done and met with NHESP and Conservation Agent. KH motioned to continue to next meeting; AL seconded AIF.

**3.1** Ratify Emergency Certification for Emery Road DH advised the soil borings failed and there is a gas leak so DH signed an Emergency Certification. KH motioned to ratify and sign the Emergency Certification, JL seconded; AIF.

**3.3** Stan Dillis – discussed conservation restriction on Coffee Farm 4 lot subdivision – regulations require a fire cistern; neighbors have a pond and they suggested to install a hydrant in pond to make it a fire pond and protect whole neighborhood; Stan advised the Fire Department supported it. Stan asked if the Conservation Commission would object to that plan; the pond is less than 5000' & 14ft deep. KH asked if any NHESP habitat are at the site; Stan advised not sure at this time and if project proceeds will file either a Request for Determination or Notice of Intent.
