 - 1.2 Chairman's additions or deletions. 3.7 delayed the reappointment of the Master Plan committee to the next Planning Board meeting. 3.8 deferred to next planning Board meeting Chairman McNally then took work session 3.5 DLTA MRPC Townend Chapter 43D feasibility grant support action items out of order and Kayla Kress presented the materials she prepared for the CH.43D feasibility study. She prepared a matrix of 8 properties analyzed with respect to the criteria that the State considers when reviewing potential Priority Development Sites. She recommended removing the Settle shop from the list due to its' small size and potential development limitations. The Board discussed reducing the list to three properties. C. Sexton-Diranian commented on prioritizing Central Plaza because the owner has interest, The Dudley Road property and the Squannacook elementary school.

[†] Per the Governor's Order, and during the State of Emergency now-in-effect or until sooner rescinded, public bodies are relieved from the requirement that they conduct their meetings in a public place that is open and physically accessible to the public; provided, however, that all public bodies shall ensure public access to deliberations through adequate, alternative means, which include (but are not limited to) telephone, internet or satellite enabled audio or video conferencing or other technology that enables the public to clearly follow the proceedings of the public body while they are occurring. The Order also allows remote participation by all members of a public body; and waives the requirements that a quorum and the chair be physically present at the meeting location.
